Amendment of *Prohibition of Harassment* **Board Policy 3.33**

- I. This policy prohibits harassment of employees and students.
- II. The proposed amendment prohibits discrimination in the education of students and employment.
- III. Legal authority for this policy is F.S. 120.54, 1001.41, 1001.42, 1012.23. Laws implemented are F.S. 112.51, 119.07, 760.01 et seq., 1000.05, 1000.21, 1001.43, 1012.22; 34 CFR 99, 34 CFR 200.43(c), P.L. 110-223.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of *Unlawful Discrimination Prohibited* **Board Policy 6.43**

- I. This policy lists guidelines for complying with state and federal laws prohibiting discrimination.
- II. The proposed amendment prohibits discrimination in the education of students and employment.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42, 1012.22, and 1012.23. Laws implemented are F.S. 1000.05, 1000.21, 1001.43, 1012.22; 28 CFR 35, 34 CFR 100, 34 CFR 104, 34 CFR 108, 34 CFR 200, P.L. 100-233. Americans with Disabilities.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of *Authorized Travel Expenses* **Board Policy 7.60***

- I. This policy establishes parameters and guidelines for reimbursement of authorized travel expenses.
- II. Proposed revisions bring the plan into compliance with Florida Statutes.
- III. Legal authority for this policy is F.S. 1001.42. Laws implemented are 112.061, 1001.39, 1001.643. State Board of Education Rules: 6A-1.056.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of *Online Information Services Use* **Board Policy 8.80**

- I. This policy provides guidelines for use of the District's online information services.
- II. The proposed amendment prohibits discrimination in the education of students and employment.
- III. Legal authority for this policy is F.S. 1001.42. Laws implemented are 1000.21 and 1001.43. State Board of Education Rules: 6A-1.0014.
- IV. This policy amendment will not affect individuals from an economic standpoint.
